

## Official Rules

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING.**

**This Sweepstakes is governed exclusively by the laws of the United States.**

**1. How to Enter.** Eligible entrants (as defined in Section 3) who are interested in participating in the Sweepstakes (“Sweepstakes”) may enter the Drawing by:

All entries must be received no later than **11:59 PM EST** on February 10, 2021. Mailed entries must be mailed in an envelope postmarked and received by the Sponsor on or before February 10, 2021.

No mechanically reproduced entries, alterations or forged entries. All entries become the sole and exclusive property of the Sponsor and receipt of entries will not be acknowledged or returned. Sponsor is not responsible for lost, late, illegible, stolen, incomplete, invalid, unintelligible or misdirected entries, which will be disqualified, or for problems of any kind whether mechanical, human or electronic. **2. Start/End Times.** Drawing entry period begins at **8:00 AM EST** on January 26, 2021 and ends at **11:59 PM EST** on February 10, 2021.

**3. Eligibility.** Participation is open only to persons that: 1) are legal residents of the fifty (50) United States or the District of Columbia; and 2) are eighteen (18) years of age or older as of date of entry. All Participants must have access to the Internet and must have an e-mail account. Void where prohibited, taxed or restricted by law. Employees, officers and directors of Discover Puerto Rico (“Sponsor”) and its parent company, subsidiaries, affiliates, partners (such as JetBlue and San Juan Marriott Resort & Stellaris Casino), advertising and promotion agencies, manufacturers or distributors of sweepstakes materials
