"FROM THE BALLPARK TO THE ISLAND" SWEEPSTAKES OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

1. SPONSOR

Corporación para la Promoción de Puerto Rico como Destino, Inc., d/b/a Discover Puerto Rico, a private, not-for-profit corporation organized under the laws of the Commonwealth of Puerto Rico, with principal offices located at 500 Calle de la Tanca, Building Ochoa, Suite 402B, San Juan, PR 00901 (the "Sponsor").

2. PROMOTION PERIOD

The "From the Ballpark to Paradise" Sweepstakes (the "Sweepstakes") consists of five (5) separate Entry Periods corresponding to Major League Baseball game dates as follows:

(a) Entry Period 1 – New York Mets: June 9, 2026 (b) Entry Period 2 – Houston Astros: July 21, 2026 (c) Entry Period 3 – Colorado Rockies: August 18, 2026 (d) Entry Period 4 – Philadelphia Phillies (Roberto Clemente Day): September 22, 2026 (e) Entry Period 5 – LA Dodgers: [August 21, 2026]

Each Entry Period begins at [JUNE 9TH] and ends at [June 10th] on the applicable date, or as otherwise specified by Sponsor (each, an "Entry Period," and collectively, the "Promotion Period"). All times are Atlantic Standard Time unless otherwise specified.

3. ELIGIBILITY

The Sweepstakes is open to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years of age or the age of majority in their jurisdiction of residence, whichever is older, at the time of entry. Residents of Puerto Rico are excluded from participation.

The following persons are not eligible to participate: employees, officers, and directors of Sponsor, Hotel Rumbao, Bacardi U.S.A., Inc., and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies, and any other entity involved in the development, administration, or fulfillment of the Sweepstakes (collectively, "Sweepstakes Entities"), and members of the immediate family (defined as spouse, parents, children, siblings, and their respective spouses, regardless of where they reside) and household members (whether or not related) of each such person.

4. HOW TO ENTER

During the applicable Entry Period, visit <https://www.discoverpuertorico.com/ballpark-to-island> and complete the official entry form with all required information, including your full name, valid email address, date of birth, and zip code. Each eligible entrant may submit one (1) entry per Entry Period. Multiple entries from the same individual during a single Entry Period will be void. Entries generated by script, macro, robotic, programmed, or any other automated means are void. All entries become the property of Sponsor and will not be returned or acknowledged.

5. WINNER SELECTION AND NOTIFICATION

One (1) potential winner will be selected by random drawing from among all eligible entries received during June 9th, 2026 and September 22, 2026. The drawing will be conducted on or about June 9th by Discover Puerto Rico, whose decisions are final and binding on all matters relating to the Sweepstakes.

The potential winner will be notified by email and/or telephone at the contact information provided at the time of entry. The potential winner must respond to the notification within [SEVEN (7)] calendar days of the date the notification is sent, or the prize will be forfeited and an alternate winner may be selected at Sponsor's sole discretion. The potential winner may be required to execute and return an Affidavit of Eligibility, a Liability Release, and (where permitted by law) a Publicity Release within [SEVEN (7) / FOURTEEN (14)] calendar days of the date of notification. Failure to timely return any required documents, or if the prize notification or prize is returned as undeliverable, will result in forfeiture of the prize.

6. PRIZE DESCRIPTION

One (1) Grand Prize will be awarded, consisting of:

- (a) One (1) round-trip to Puerto Rico, valid from any destination in the continental United States;
- (b) A complimentary four (4)-day/(3)-night hotel stay in a Traditional King room at Hotel Rumbao, for a maximum of two (2) adults; and
- (c) One (1) Rum Mixology Class experience at Casa Bacardi in Puerto Rico for the winner and one (1) guest.

Approximate Retail Value ("ARV") of Grand Prize: \$3,000

7. PRIZE CONDITIONS AND RESTRICTIONS

General: Prize is awarded "as is" with no warranty or guarantee, express or implied. No substitution, transfer, or cash equivalent of prize or any prize component is permitted, except at Sponsor's sole discretion. Sponsor reserves the right to substitute a prize of equal or greater value if the advertised prize (or any component thereof) becomes unavailable. All federal, state, and local taxes (including income taxes) on the prize are the sole responsibility of the winner. Winner may be issued an IRS Form 1099-MISC or

other applicable tax form for the value of the prize. Winner must provide a valid Social Security Number or Taxpayer Identification Number prior to prize fulfillment for tax reporting purposes.

Flight Certificate Restrictions: Each flight certificate is good for one-time use by one person. All travel must be booked and flown within the specified validity dates. Certificates cannot be partially redeemed, are not redeemable for cash, and have no cash value. Checked bags are not included and winner is responsible for bag fees, oversized, overweight, or extra baggage and fees for products/services sold separately. DPR is not responsible for lost or stolen flight Certificates or access credentials.

Hotel Restrictions: The hotel stay is subject to availability at the time of booking. The offer is not transferable and cannot be used at any other Marriott or Tribute Portfolio hotel property. Upon prize award, the winner's name and email address will be provided to the hotel partner for disbursement of a complimentary certificate. The hotel certificate will not be replaced if lost, nor extended if expired. Expiration is typically one (1) year from the date of disbursement. All hotel incidentals, room upgrades, resort fees (if any), room service, and expenses not specifically included in the prize description are the sole responsibility of the winner. The hotel stay must be redeemed within one (1) year from the date of the certificate issuance, subject to blackout dates and availability.

Casa Bacardi Rum Mixology Class: The experience is subject to scheduling availability and must be redeemed within one (1) year of prize notification. Winner and guest must be at least twenty-one (21) years of age to participate in the Rum Mixology Class. Winner is responsible for transportation to and from the Casa Bacardi facility. The experience is non-transferable.

Travel Restrictions: All travel arrangements are subject to availability and must be completed within one (1) year of prize notification, unless otherwise specified. All components of the trip not expressly included in the prize description (including but not limited to ground transportation, meals, tips, incidentals, personal expenses, and travel insurance) are the sole responsibility of the winner.

8. ODDS OF WINNING

The odds of winning depend on the total number of eligible entries received during the applicable Entry Period(s).

9. RELEASE OF LIABILITY AND INDEMNIFICATION

By entering the Sweepstakes, each entrant agrees to release, discharge, indemnify, and hold harmless Sponsor, Hotel Rumbao, Bacardi U.S.A., Inc., and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies, and all of their respective officers, directors, employees, agents, representatives, successors, and assigns (collectively, the "Released Parties") from and against any and all claims, damages, losses, costs, expenses, or liability (including reasonable attorneys' fees) arising out of or in connection with: (a) participation in the Sweepstakes or any Sweepstakes-related activity; (b) acceptance, receipt, possession,

use, or misuse of the prize or any component thereof (including, without limitation, any travel or activity related thereto); (c) any injury, damage, loss, or expense of any kind arising from or related to the prize, including but not limited to personal injury, death, or property damage; and (d) any claims based on publicity rights, defamation, invasion of privacy, copyright infringement, trademark infringement, or any other intellectual property-related cause of action.

Entrant further agrees that in any cause of action, the Released Parties' liability will be limited to the cost of entering and participating in the Sweepstakes, and in no event shall the Released Parties be liable for attorney's fees. Entrant waives the right to claim any damages whatsoever, including but not limited to punitive, consequential, direct, or indirect damages.

10. PUBLICITY RIGHTS

Except where prohibited by law, acceptance of the prize constitutes the winner's consent for Sponsor and its designees to use the winner's name, likeness, photograph, voice, biographical information, statements, city, and state of residence for advertising, promotional, and publicity purposes in any and all media now known or hereafter devised, worldwide, in perpetuity, without additional compensation, notice, review, or consent.

11. GENERAL CONDITIONS

Sponsor reserves the right, in its sole discretion, to cancel, terminate, modify, or suspend the Sweepstakes (or any portion thereof) if fraud, technical failures, human error, or any other factor impairs the integrity or proper functioning of the Sweepstakes, as determined by Sponsor in its sole discretion. In such event, Sponsor may, at its discretion, select winner(s) from among all eligible, non-suspect entries received prior to the action taken. Sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers with the entry process or the operation of the Sweepstakes, who acts in violation of these Official Rules, or who acts in a disruptive or unsportsmanlike manner. Any attempt by any person to deliberately damage or undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and should such an attempt be made, Sponsor reserves the right to seek remedies and damages to the fullest extent permitted by law.

CAUTION: ANY ATTEMPT BY AN ENTRANT OR ANY OTHER INDIVIDUAL TO DELIBERATELY DAMAGE OR UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS. SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES AND OTHER REMEDIES (INCLUDING ATTORNEYS' FEES) FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW.

12. LIMITATIONS OF LIABILITY

The Released Parties are not responsible for: (a) incorrect or inaccurate entry information, whether caused by entrant, printing errors, or by any of the equipment or programming associated with or utilized in the Sweepstakes; (b) technical failures of

any kind, including but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (c) unauthorized human intervention in any part of the entry process or the Sweepstakes; (d) technical or human error that may occur in the administration of the Sweepstakes or the processing of entries; (e) any injury or damage to persons or property that may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes or receipt or use or misuse of any prize; or (f) late, lost, stolen, misdirected, illegible, incomplete, or unintelligible entries or communications. If, for any reason, an entrant's entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, the entrant's sole remedy is another entry in the Sweepstakes.

13. DISPUTES AND GOVERNING LAW

These Official Rules and all issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules, or the rights and obligations of entrant and Sponsor in connection with the Sweepstakes, shall be governed by and construed in accordance with the laws of the Commonwealth of Puerto Rico, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other jurisdiction's laws. Any dispute arising out of or in connection with the Sweepstakes shall be subject to the exclusive jurisdiction of the courts of the Commonwealth of Puerto Rico, specifically the Court of First Instance, San Juan Part, or the United States District Court for the District of Puerto Rico, and each entrant consents to the personal jurisdiction of such courts and waives any objection to the exercise of jurisdiction over the parties by such courts and to the venue of such courts.

14. PRIVACY

By entering the Sweepstakes, each entrant acknowledges and agrees that Sponsor may collect and use the personal information submitted in connection with the entry for purposes of administering the Sweepstakes, as outlined in Sponsor's Privacy Policy available at <https://www.discoverpuertorico.com/info/privacy-policy>. Personal information collected from entrants will be handled in accordance with all applicable privacy laws and regulations, including applicable provisions of the Puerto Rico Data Protection Act and any applicable U.S. federal privacy regulations. Entrant's personal information may be shared with third-party service providers engaged by Sponsor solely for purposes of administering and fulfilling the Sweepstakes.

15. PUERTO RICO REGULATORY COMPLIANCE

Under Puerto Rico Act No. 36 of 2019 (as amended) and the Regulations of the Puerto Rico Treasury Department governing games of chance and promotions, Sponsor must evaluate whether the total value of the prizes offered in this Sweepstakes triggers the requirement to obtain a promotional permit from the Puerto Rico Treasury Department (Departamento de Hacienda). If the aggregate ARV of all prizes exceeds the applicable threshold, Sponsor must file the requisite application and post any required bond or deposit prior to the commencement of the Sweepstakes. Sponsor should consult with local counsel to determine whether registration, bonding, or

permit requirements apply based on the final ARV of the prize package and the geographic scope of the promotion.

16. WINNER LIST

For the name of the winner, send an email to website@discoverpuertorico.com to be received no later than 90 DAYS AFTER FINAL DRAWING.

17. SEVERABILITY

If any provision of these Official Rules is found to be invalid, illegal, or unenforceable by a court of competent jurisdiction, such finding shall not affect the validity of the remaining provisions, which shall remain in full force and effect.

18. FORCE MAJEURE

If, for any reason, the Sweepstakes (or any part thereof) is not capable of running as planned by reason of acts of God, natural disasters, pandemics, epidemics, government orders or regulations, war, terrorism, strikes, labor disputes, civil disturbance, or any other cause beyond Sponsor's reasonable control that corrupts or impairs the administration, security, fairness, or proper conduct of the Sweepstakes, Sponsor reserves the right, in its sole discretion, to cancel, terminate, modify, or suspend the Sweepstakes and select the winner(s) from among all eligible entries received prior to such cancellation, termination, modification, or suspension.
