“HUNT FOR LOVE TRIP OF A LIFETIME” SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. OPEN TO NATURAL PERSONS WHO ARE LEGAL RESIDENTS OF THE 50 UNITED STATES AND THE DISTRICT OF COLUMBIA, EXCLUDING RESIDENTS OF PUERTO RICO AND ALL OTHER U.S. TERRITORIES AND POSSESSIONS, 18 YEARS OF AGE OR OLDER, AS OF TIME OF ENTRY. VOID WHERE PROHIBITED BY LAW AND OUTSIDE THE ELIGIBILITY AREA.

Official Rules

1. Sponsor

The sponsor of the TLC®: 90 Day: Hunt for Love™ “Hunt for Love Trip of a Lifetime” Sweepstakes (the “Sweepstakes”) is Corporación para la Promoción de Puerto Rico como Destino, Inc., d/b/a Discover Puerto Rico, a private, not-for-profit corporation organized under the laws of the Commonwealth of Puerto Rico, with principal offices located at 500 Calle de la Tanca, Building Ochoa, Suite 402B, San Juan, Puerto Rico 00901 (the “Sponsor”).

Discovery Communications, LLC, Warner Bros. Discovery, Inc., and the TLC®, 90 Day Fiancé® and 90 Day: Hunt for Love™ brands, and their respective parent, subsidiary, affiliated, and related entities (collectively, the “TLC Parties”) are not sponsors or administrators of the Sweepstakes. The TLC Parties’ roles are limited to approval of the use of TLC Parties’ Trademarks (defined below), promotional support as agreed with Sponsor, and collaboration with Sponsor regarding mutually agreed winner-selection criteria and promotional materials.

2. Sweepstakes Overview

The Sweepstakes is a co-branded consumer promotion celebrating TLC’s 90 Day: Hunt for Love™ television show and Puerto Rico as a destination for romance, travel, adventure, culture, nightlife, and connection. Eligible entrants will have the opportunity to enter for a chance to win a Puerto Rico travel prize package inspired by the campaign. The Sweepstakes is governed

exclusively by these Official Rules and by the decisions of Sponsor, which are final and binding in all matters relating to the Sweepstakes.

3. Promotion Period

The Sweepstakes begins at 12:00:00 a.m. Atlantic Standard Time (“AST”) on September 28, 2026 and ends at 11:59:59 p.m. AST on January 25, 2027 (the “Promotion Period”). Sponsor’s server or other Sponsor-designated timekeeping system is the official timekeeping device for the Sweepstakes. Entries received before or after the Promotion Period are void.

If the series premiere date, campaign schedule, or any material campaign component is delayed, suspended, or otherwise realigned, Sponsor may revise the Sweepstakes schedule in accordance with applicable law and these Official Rules.

4. Eligibility

The Sweepstakes is open only to natural persons who are legal residents of the fifty (50) United States and the District of Columbia, excluding residents of Puerto Rico and all other U.S. territories and possessions, and who are at least eighteen (18) years of age or the age of majority in their jurisdiction of residence, whichever is older, at the time of entry. Void in Puerto Rico, outside the fifty (50) United States and the District of Columbia, including all other U.S. territories and possessions, and where prohibited or restricted by law.

NOTICE TO RESIDENTS OF PUERTO RICO: This Sweepstakes is not open to residents of the Commonwealth of Puerto Rico. Residents of Puerto Rico are not eligible to enter or win. This exclusion applies notwithstanding the fact that Sponsor is domiciled in Puerto Rico.

The following persons are not eligible to enter or win: employees, officers, directors, contractors, representatives, and agents of Sponsor, Administrator, the TLC Parties, any prize provider, airline, hotel, travel partner, advertising or promotion agency, or any other person or entity involved in the development, administration, judging, promotion, or fulfillment of the Sweepstakes (collectively, the “Sweepstakes Entities”); and the immediate family members and household members of each such person. “Immediate family members” means spouse, domestic partner, parent, child, sibling, and each of their respective spouses, whether or not residing in the same household. “Household members” means persons who share the same residence for at least three (3) months during the twelve (12)-month period preceding the start of the Promotion Period, whether or not related.

If any prize component includes alcohol, nightlife, age-restricted venues, or other age-restricted activities, the winner and any guest participating in such component must be at least twenty-one (21) years of age or must accept an age-appropriate substitute component selected by Sponsor in its sole discretion.

5. How to Enter; No Purchase Necessary

During the Promotion Period, visit <https://www.discoverpuertorico.com/hunt-for-love> or on DiscoverPuertoRico.com and complete and submit the official entry form with all required information, which may include your full legal name, valid email address, telephone number, date of birth, state of residence, ZIP code, and any required eligibility certifications. You must check the box confirming that you have read and agree to these Official Rules.

No purchase, payment, booking, text message, social media post, newsletter subscription, or consent to receive marketing communications is necessary to enter or win. A purchase, payment, booking, text message, social media post, newsletter subscription, or marketing opt-in will not increase your chances of winning. Any opt-in to receive marketing communications from Sponsor, the TLC Parties, or any third party is optional and is not a condition of entry.

Limit: one (1) entry per person and per email address during the Promotion Period. Multiple, bulk, automated, scripted, robotic, programmed, duplicate, incomplete, inaccurate, late, lost, misdirected, or fraudulent entries are void. Sponsor may disqualify any entrant who attempts to enter through multiple identities, email addresses, devices, accounts, or other methods that Sponsor determines are intended to evade the entry limit or undermine the integrity of the Sweepstakes.

If the entry form requests optional responses, stories, travel preferences, quiz results, or other content, such content will be used for engagement, eligibility verification, administration, marketing, analytics, or other disclosed purposes only and will not be judged or used to increase or decrease an entrant's odds of winning.

6. Entry Content Requirements

All entry information and any submitted content must be truthful, complete, and lawful. Entries and any related content must not:

- contain false, misleading, defamatory, obscene, hateful, discriminatory, harassing, threatening, indecent, violent, sexually explicit, political, or otherwise inappropriate material;
- depict, encourage, or reference unlawful conduct, unsafe conduct, illegal drugs, unlawful alcohol consumption, or alcohol consumption by anyone under twenty-one (21) years of age;

- violate or infringe any copyright, trademark, privacy, publicity, moral, contractual, proprietary, or other third-party right;
- misuse any Discover Puerto Rico, TLC®, Warner Bros. Discovery, Inc. Discovery Communications, LLC, 90 Day Fiancé®, 90 Day: Hunt for Love™, or third-party name, logo, mark, image, clip, music, likeness, or other intellectual property;
- include any statement or reference relating to Puerto Rico politics or Puerto Rico political status;
- include malware, code, links, or material that could impair the operation, security, or fairness of the Sweepstakes or any Sponsor, TLC Party, or third-party system; or
- violate these Official Rules, platform rules, or any applicable federal, state, local, or Puerto Rico law, rule, or regulation.

Sponsor may reject, void, or disqualify any entry or entrant that Sponsor determines, in its sole discretion, violates these Official Rules or may harm the goodwill, reputation, neutrality, safety, or integrity of Sponsor, Puerto Rico as a destination, the TLC Parties, or the Sweepstakes.

7. Prize; Approximate Retail Value

One (1) grand prize will be awarded, consisting of a Puerto Rico travel package inspired by TLC's 90 Day: Hunt for Love™ (the "Prize"). The Prize includes the following components selected by Sponsor in its sole discretion:

- Round-trip economy-class air transportation for winner and [one (1)] guest from a major USA airport near winner's residence to San Juan, Puerto Rico (SJU). Any changes, upgrades, baggage fees, ground transportation, meals, or other expenses not expressly included in the prize are the responsibility of the winner and guest. Airline tickets/certificates are non-transferable, non-refundable, and not redeemable for cash, except as otherwise determined by Sponsor. Sponsor is not responsible for flight cancellations, delays, schedule changes, or other travel disruptions outside its control.
- A four (4)-night stay for two (2) guests at La Concha Resort Puerto Rico in a One-Bedroom Oceanfront Suite. Price included daily breakfast buffet for two (2) guests, and dinner for two (2) at Levant by Chef Michael White. The certificate is valid for redemption between October 1, 2026, and October 1, 2027. Advance reservations are required and subject to availability. Applicable taxes, resort fees, parking, and any additional charges incurred during the stay are not included. Certain restrictions and blackout dates may apply, including holidays and long weekends. The certificate is non-transferable, cannot be redeemed for cash or credit, and cannot be combined with other promotions, discounts, or group bookings.

- A certificate for two (2) guests to experience Toro Verde Adventure Park in Orocovis, Puerto Rico. Advance reservations are required and subject to availability. Participants must comply with all applicable safety requirements, including height and weight restrictions based on the selected activity. Additional restrictions may apply.
- (2) gift certificates valued at \$100 each for food and beverage consumption at participating establishments at DISTRITO T-Mobile. The certificate has no cash value and may not be redeemed for cash. Additional charges exceeding the value of the certificate are the sole responsibility of the winner.
- A curated Puerto Rico itinerary inspired by romance, adventure, nightlife, culture, relaxation, and/or locations and experiences featured or thematically referenced in the 90 Day: Hunt for Love campaign;

Approximate Retail Value (“ARV”) of the Prize: US \$4,900. Total ARV of all prizes: US \$4,900. If the actual value of any Prize component differs from the stated ARV, winner will not receive the difference in cash or otherwise.

All Prize details not expressly specified in these Official Rules will be determined by Sponsor in its sole discretion. Prize is awarded “as is,” without warranty or guarantee, express or implied, except any standard manufacturer, carrier, hotel, travel provider, or experience-provider warranty that may be provided directly by the applicable provider. Sponsor may substitute a prize or prize component of equal or greater value if the stated Prize or any component becomes unavailable, impracticable, unlawful, or inadvisable for any reason. No cash redemption, transfer, assignment, or substitution is permitted except by Sponsor.

8. Prize Conditions and Travel Restrictions

Winner and guest must travel together on the same itinerary and must complete travel by [INSERT DEADLINE]. Travel must be round-trip and is subject to availability, blackout dates, travel restrictions, schedule changes, capacity controls, weather, public health conditions, governmental directives, and the terms and conditions of airlines, hotels, transportation providers, venues, and other prize providers. If, in the sole judgment of Sponsor, air travel is not required due to the winner’s proximity to San Juan, Puerto Rico, air transportation may be substituted with another method of transportation at Sponsor’s sole and absolute discretion. The actual value of the Prize may vary depending on points of departure, airfare fluctuations, hotel rates, or other factors. Any difference between the stated approximate retail value and the actual value of the Prize will not be awarded. No refund, compensation, or substitution will be provided in the event of any cancellation, delay, rescheduling, or interruption of any flight, transportation, accommodation, activity, or other Prize component.

Sponsor will not be responsible for any delay, cancellation, substitution, postponement, missed connection, lost document, baggage issue, personal expense, or other travel-related issue not expressly stated as included in the Prize.

Winner and guest are solely responsible for all costs and expenses not expressly stated as included, including ground transportation not specified, baggage fees, seat upgrades, excursions, meals, beverages, gratuities, travel insurance, passports or identification documents, incidentals, security fees, parking, telephone charges, internet charges, souvenirs, medical expenses, taxes, and any other expenses associated with accepting, receiving, using, or misusing the Prize. Winner and guest acknowledge that Sponsor has not obtained and will not obtain travel insurance or any other form of insurance on their behalf.

Winner and guest must have and are solely responsible for obtaining all required travel documents, identification, permissions, and authorizations. Guest must be of legal age of majority in guest's jurisdiction of residence or must be the winner's child/legal ward or have written permission from the guest's parent/legal guardian in a form acceptable to Sponsor. Sponsor may require winner and guest to execute liability releases, publicity releases, travel releases, tax forms, and other documents reasonably required by Sponsor or any prize provider. If any required documents are not timely completed and returned, Sponsor may, in its sole discretion, disqualify the guest, require an alternate guest, permit the winner to travel without a guest, or declare the Prize forfeited in whole or in part. If winner elects to partake in any or all portions of the Prize with no guest, any unused portions of the Prize will be forfeited and no substitutions will be provided.

If, for any reason, winner cannot accept or use the Prize as stated, winner may forfeit the Prize in its entirety and Sponsor may select an alternate winner. Sponsor is not required to provide any cash equivalent or substitute travel if winner is unable or unwilling to travel on the dates, itinerary, or terms offered by Sponsor.

Participation in Prize-related travel and activities is subject to all applicable laws, regulations, venue rules, travel requirements, and public health protocols in effect at the time of travel. Winner and guest must comply with all such requirements. Failure to comply may result in forfeiture of all or a portion of the Prize without compensation.

Winner and guest acknowledge that travel and attendance at public venues may involve inherent risks, including exposure to communicable diseases. By accepting the Prize, winner and guest voluntarily assume all risks associated with travel and participation in Prize activities.

9. Winner Selection; Odds

On or about [INSERT DRAWING DATE], Sponsor or Administrator will select one (1) potential winner in a random drawing from among all eligible entries received during the Promotion Period. Odds of winning depend on the number of eligible entries received.

For avoidance of doubt, winner selection will be conducted by random drawing and will not be based on the quality, popularity, creativity, emotional appeal, or content of any story, answer, photo, quiz response, or other optional submission.

10. Winner Notification and Verification

Potential winner will be notified by email, telephone, or other contact information provided at entry. Potential winner must respond within [five (5) business days / seven (7) calendar days] after Sponsor's first notification attempt or the Prize may be forfeited and awarded to an alternate potential winner. Sponsor may require potential winner to complete, sign, notarize if required, and return an affidavit or declaration of eligibility, liability release, publicity release where lawful, tax forms, travel documents, and any other documents reasonably required by Sponsor or any prize provider within the timeframe specified by Sponsor.

Sponsor may require proof of identity, age, residence, and eligibility. If a potential winner is ineligible, fails to respond, fails to timely return required documents, provides incomplete or inaccurate information, cannot accept the Prize as stated, violates these Official Rules, or if any prize notification or Prize is returned as undeliverable, the potential winner may be disqualified and an alternate potential winner may be selected by random drawing from among remaining eligible entries. Sponsor will use commercially reasonable efforts to award the Prize; however, if the Prize remains unclaimed after 2 alternate attempts, Sponsor may dispose of the Prize in accordance with applicable law.

11. Taxes

Winner is solely responsible for all federal, state, local, Puerto Rico, and other taxes, fees, and costs associated with acceptance, receipt, possession, or use of the Prize. If required by law, Sponsor will issue an IRS Form 1099-MISC or other tax reporting form to winner for the calendar year in which the Prize is awarded. Winner must provide any taxpayer identification information and documentation reasonably required by Sponsor as a condition of receiving the Prize.

12. Publicity

Except where prohibited by law, acceptance of the Prize constitutes winner's consent for Sponsor, the TLC Parties, Administrator, prize providers, and their respective designees to use winner's name, likeness, photograph, voice, biographical information, city and state of residence,

Prize information, statements, and any submitted content for advertising, publicity, promotional, trade, social media, public relations, and other commercial purposes in any media now known or later developed, worldwide in perpetuity, without additional compensation, notice, review, or approval.

Sponsor may require winner and guest to execute a publicity release before awarding or fulfilling the Prize. Sponsor is not required to use any winner information or materials.

13. Privacy; Data Use

Information collected in connection with the Sweepstakes will be used to administer the Sweepstakes, verify eligibility, notify and verify potential winners, fulfill prizes, communicate with entrants, comply with legal obligations, protect Sponsor's rights, and for any other purpose disclosed at the point of collection or described in Sponsor's Privacy Policy, available at <https://www.discoverpuertorico.com/info/privacy-policy>.

Marketing communications and data sharing with the TLC Parties or other third parties are optional unless expressly required for prize fulfillment. Sponsor will not share entrant personal information with the TLC Parties for their independent marketing unless the entrant provides appropriate consent or another lawful basis applies. Any sharing of participant data with the TLC Parties or other third parties must be limited to the purposes disclosed to entrants and must be subject to appropriate data protection, security, retention, and use restrictions, as well as the TLC Parties' privacy policy, available at <https://www.wbdprivacy.com/policycenter/b2c/en-us/>.

By entering, entrants acknowledge that personal information may be processed in Puerto Rico and the United States and may be shared with service providers, TLC Parties, Administrator, prize providers, and other third parties solely as reasonably necessary to administer, promote, verify, and fulfill the Sweepstakes, comply with law, and protect the rights and safety of Sponsor, entrants, and the public.

14. General Conditions

Sponsor reserves the right, in its sole discretion and to the fullest extent permitted by applicable law, to cancel, terminate, modify, suspend, or postpone the Sweepstakes or any portion of the Sweepstakes if Sponsor determines that fraud, technical failures, human error, weather, public health conditions, governmental action, platform changes, force majeure, unauthorized intervention, or any other factor impairs or may impair the integrity, administration, security, fairness, legality, or proper conduct of the Sweepstakes. In such event, Sponsor may select winner(s) from among all eligible, non-suspect entries received before the action taken, or may take any other action Sponsor determines is fair, equitable, and legally compliant.

Sponsor may disqualify any entrant who tampers with the entry process or operation of the Sweepstakes, violates these Official Rules, acts in a disruptive, unsportsmanlike, harassing, fraudulent, unlawful, or inappropriate manner, attempts to undermine the legitimate operation of the Sweepstakes, or damages or disparages the goodwill or reputation of Sponsor, Puerto Rico as a destination, the TLC Parties, or any Sweepstakes Entity.

ANY ATTEMPT BY AN ENTRANT OR ANY OTHER PERSON TO DELIBERATELY DAMAGE ANY WEBSITE, PLATFORM, OR SYSTEM OR TO UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAW. SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES AND OTHER REMEDIES, INCLUDING ATTORNEYS' FEES, FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW.

15. Release; Limitation of Liability

By entering, each entrant agrees to release, discharge, indemnify, defend, and hold harmless Sponsor, Administrator, the TLC Parties, any airline, hotel, transportation provider, prize provider, social media platform, advertising or promotion agency, and each of their respective parent companies, subsidiaries, affiliates, successors, assigns, officers, directors, employees, contractors, representatives, and agents (collectively, the "Released Parties") from and against any and all claims, demands, losses, damages, costs, expenses, liabilities, injuries, death, property damage, rights of publicity claims, privacy claims, defamation claims, intellectual property claims, and causes of action of any kind arising out of or relating to: (a) participation in the Sweepstakes; (b) acceptance, receipt, possession, use, or misuse of any Prize or Prize component; (c) any travel or activity related to the Sweepstakes or Prize; (d) any entry, submitted content, or entrant conduct; (e) any technical, printing, typographical, human, administrative, platform, network, electronic, computer, or other error; or (f) any matter beyond the Released Parties' reasonable control.

To the fullest extent permitted by applicable law, the Released Parties are not responsible for indirect, incidental, consequential, special, punitive, or exemplary damages, attorneys' fees, or any damages other than entrant's actual out-of-pocket costs of entering the Sweepstakes, if any. Nothing in these Official Rules is intended to limit liability for gross negligence, willful misconduct, fraud, or any liability that cannot be limited or excluded under applicable law.

This Sweepstakes is in no way sponsored, endorsed, administered by, or associated with Meta, Instagram, Facebook, X, TikTok, YouTube, or any other social media platform unless expressly stated by Sponsor. Entrants release each such platform from any and all liability arising from or relating to the Sweepstakes.

16. Force Majeure

If the Sweepstakes, campaign, travel, or any Prize-related activity is delayed, modified, suspended, canceled, or made impracticable due to acts of God, hurricanes, tropical storms, severe weather, natural disasters, epidemics, pandemics, public health directives, labor disputes, strikes, civil disturbance, terrorism, war, governmental action, changes to the TLC broadcast schedule, platform outages, supplier issues, or any other cause beyond Sponsor's reasonable control, Sponsor may, to the fullest extent permitted by applicable law, modify, suspend, terminate, or reschedule the Sweepstakes or Prize-related activity and/or award the Prize in a manner that Sponsor determines is fair, equitable, and legally compliant.

17. Puerto Rico Regulatory Compliance

Sponsor will administer the Sweepstakes in accordance with applicable federal, state, local, and Puerto Rico laws, rules, and regulations, including Puerto Rico Act No. 36 of 2019, as amended, and any applicable Puerto Rico Treasury Department, Department of Consumer Affairs, Gaming Commission, or other Commonwealth rules governing games of chance, contests, promotions, consumer advertising, and prize promotions.

The full Official Rules will be posted on the Sweepstakes website <https://www.discoverpuertorico.com/hunt-for-love> or otherwise made available as required by law.

Any manufacturer, carrier, hotel, or prize-provider warranty or documentation supplied with a Prize component will be provided to the winner to the extent required by law. Unclaimed or forfeited prizes will be handled in accordance with applicable law and may be awarded to alternate winners through a commercially reasonable method selected by Sponsor.

18. Advertising, Social Media, and TLC/WBD Guidelines

No participant, influencer, agency, vendor, or partner may state or imply that any person, destination, product, entity, or campaign is endorsed by Sponsor or the TLC Parties except as expressly approved in writing.

If Sponsor, the TLC Parties, or any participant, influencer, partner, or vendor posts or shares content in exchange for a Sweepstakes entry or other incentive, the post must clearly and conspicuously disclose the promotion connection, must identify the post as a promotion entry where applicable, and must comply with platform rules.

Official Rules links must be clearly labeled as rules and should not be hidden behind an unidentified shortened link.

Suggested disclosure for posts that are entries or promote entry: "NO PURCHASE NECESSARY. Void where prohibited. See Official Rules: [URL]."

19. Disputes; Governing Law; Forum

Except where prohibited, these Official Rules and all issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules, or the rights and obligations of entrant and Sponsor in connection with the Sweepstakes, excluding TLC Parties Claims (defined below), are governed by and construed in accordance with the laws of the Commonwealth of Puerto Rico, without giving effect to any choice-of-law or conflict-of-law rule that would cause the application of the laws of any jurisdiction other than Puerto Rico.

Before initiating any legal proceeding, entrant agrees to first contact Sponsor in writing at [INSERT EMAIL ADDRESS] to attempt to resolve the dispute informally. Sponsor will endeavor to respond within thirty (30) calendar days. If the dispute is not resolved within sixty (60) calendar days after Sponsor receives entrant's written notice, either party may proceed with formal legal action.

Any dispute, claim, or cause of action arising out of or relating to the Sweepstakes or any Prize must be brought individually and not as part of any class, collective, consolidated, private attorney general, or representative action. Subject to any non-waivable rights under applicable law, any such dispute, claim, or cause of action must be brought exclusively in the courts located in San Juan, Puerto Rico, including the Court of First Instance, San Juan Part, or the United States District Court for the District of Puerto Rico, if federal jurisdiction exists. Each entrant consents to the personal jurisdiction and venue of such courts and waives any objection to such jurisdiction or venue.

Any disputes, claims, and causes of action against any of the TLC Parties arising out of or relating to any person's participation in this Sweepstakes or use of or participation in any portion of the Prize (collectively, "TLC Parties Claims") shall be resolved by applying the laws of the State of New York without giving effect to any choice of law or conflict of law rules or provisions which would cause the application of the laws of any jurisdiction other than the State of New York. Any action or litigation concerning TLC Parties Claims shall take place exclusively in the federal or state courts sitting in New York County, New York, and each entrant expressly consents to the jurisdiction of and venue in such courts and waives all defenses of lack of jurisdiction and inconvenient forum with respect to such courts. Any and all disputes, claims, and causes of action arising out of or in connection with TLC Parties Claims shall be resolved individually, without resort to any form of class action. Each entrant agrees to service of process by mail or other method acceptable under the laws of the State of New York.

20. Severability; No Waiver
